1. The Ghana Grid Company Limited (GRIDCo) of the Republic of Ghana intends to apply part of its budgetary allocation to fund eligible payments under the Contract for **Stringing of Optical Ground Wire (OPGW) Cables at various locations**
2. GRIDCo invites sealed tenders from eligible Contractors who have registered with the Public Procurement Authority for the **stringing of Optical Ground Wire (OPGW) Cables at various locations (Lots)**. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003, Act 663, as amended and in the Guidelines of the Public Procurement Authority of the Republic of Ghana.
3. Interested eligible Tenderers may obtain the Tendering Document and further information from the address below from **09:00 to 15:00 hours GMT from Monday, October 21, 2019 to Thursday, November 21, 2019** each working day:
4. A complete set of Tendering documents in English should be purchased at the office of the address stated below for a non-refundable fee of Two Hundred Ghana Cedis (GH¢200.00) for each set in cash or Bank Draft in the name of Ghana Grid Company Limited.
5. Tendering Documents shall be available for sale from Monday, **October 21, 2019**.

Any Tenderer who purchases a Tendering Document on behalf of another or submits a Tender in a name other than the original Purchaser of the Tendering document should provide documentary evidence from the other entity mandating them to do so, **failure of which will result in rejection of Tender**.

6. Tenders shall be completed, sealed and marked **“TENDER – STRINGING OF OPGW CABLES AT VARIOUS LOCATIONS” (indicate Lot number and name)** and delivered to the address below, on **Thursday, November 21, 2019 by 12:00noon GMT**.

All Tenders must be accompanied by a Tender Security of **Five Thousand Ghana Cedis (GH¢5,000.00) for each lot**.

Tenders shall be valid up to **148 days** after the deadline of Tender submission.

Tenderers who wish to tender for more than one lot must necessarily package each lot separately, complete with all stipulated requirements.

In filling out the tender, the Contract name shall always end with the Lot Number and Name (in bracket) of the particular Lot; for e.g. the Contract for Lot 1 shall read: Stringing of OPGW Cables at Various Locations [Lot 1: Winneba-Cape Coast (Tower 172), Cape Coast-Winneba (Tower 22), Aboadze-Cape Coast].

7. Tenders will be opened in the presence of representatives of Tenderers who choose to attend the Tender Opening at the Conference Room of the Central Warehouse, Tema immediately after 12:00noon GMT on **Thursday, November 21, 2019. Late submissions will be rejected. Electronic Tendering is not permitted.**
