INVITATION FOR TENDERS

The Ghana Grid Company Ltd. (GRIDCo) intends to apply part of its budgetary allocation to fund eligible payments under the contract for the **Installation of Two (2No.) Towers on the 161 kV Takoradi-Tarkwa Transmission Line (R1T).**

- 1) The Scope of the Works comprises but is not limited to:
 - Dismantling/decommissioning of existing one (1No.) single circuit suspension tower complete and handing over of the tower members, hardware and accessories to GRIDCo at the 161kV Takoradi Substation for storage.
 - Demolition of the reinforced concrete foundation of one (1No.) decommissioned single circuit suspension tower to a depth of 300mm below the ground level.
 - Sorting of Tower members, hardware, and accessories at GRIDCo warehouse, transportation to site and offloading for the works.
 - Fabrication of missing members and any missing hardware and accessories.
 - Installation and stringing of two (2) single circuit 161kV Transmission Line AO and DO towers fitted with 3No. AAC conductors, 1 x 282 mm² AAC (Mistletoe) conductors per phase with two (2) shield wires, one of which shall be optical ground wire (OPGW) equipped with hardware and accessories accompanied with all other associated civil works.
- 2) The estimated period for the completion of the project is Six (6) Months.
- 3) GRIDCo now invites sealed Tenders from eligible Contractors registered with the Public Procurement Authority to tender for the **Installation of Two (2No.) Towers on the 161 kV Takoradi - Tarkwa Transmission Line (R1T).**
- 4) Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003 (Act 663) as amended with (Act 914) and in accordance with the Guidelines of the Public Procurement Authority of the Republic of Ghana.
- 5) Interested eligible Tenderers may obtain further information from the Ghana Grid Company (GRIDCo) and inspect the Tendering Documents at the address **(1)** given below, from **Tuesday, January 21, 2020 to Thursday, February 20, 2020 between 09:00hrs to 15:00hrs GMT each working day.**
- 6) A complete set of Tendering Documents in English may be purchased by interested Tenderers upon the submission of a written application to the address **(2)** below between **09:00 hrs to 15:00 hrs GMT** each working day, and upon the payment of a non-refundable fee of **Two Hundred Ghana Cedis (GHS 200.00).** The method of payment shall be by cash or Bank Draft in the name of the Ghana Grid Company Limited (GRIDCo).

Tendering Documents are expected to be available for sale from **Tuesday, January 21, 2020.**

Any Tenderer who purchases a Tendering Document on behalf of another or submits a Tender in a name other than the original Purchaser of the Tendering document should provide documentary evidence from the other entity mandating them to do so. **Failure of which will result in rejection of Tender.**

A Pre-Tender meeting and site visit will be organized by the Employer on **Tuesday, February 04, 2020**. Interested Tenderers are to meet at **9.00 hrs GMT** at the 161kV GRIDCo Takoradi Substation for the Site Visit.

Interested Tenderers should confirm participation by email to engineeringprocurement@gridcogh.com by close of day on **Thursday, February 03, 2020**. Tenderers must come along with their PPEs for the site visit. The cost of the Site Visit shall be borne by Tenderers.

Tenders shall be completed, sealed and marked **“Installation of Two (2No.) Towers on the 161 kV Takoradi-Tarkwa Transmission Line (R1T) and delivered to address (3) indicated below.**

Tenders shall be valid up to **180 days** after the deadline of Tender submission. All Tenders must be accompanied by a Tender Bond of **Five Thousand Ghana Cedis (GHS 5,000.00)** issued by an Insurance company acceptable to GRIDCo and in the appropriate form and format included in the Tendering Document.

Late Tenders will be rejected. Electronic Tendering is not permitted.

Tenders will be opened in the presence of the Tenderers’ representatives, who choose to attend, at the Conference Room of the GRIDCo Procurement Warehouse, Head Office, Tema, immediately after close of Tenders at **11:00 hrs. GMT on Thursday, February 20, 2020** at the address **(3)** below;
